### **Privacy Policy for Goniec Polski**

At Goniec Polski we respect your privacy and we promise to:

- Use your personal information only to provide you with the information you have requested or agreed to receive.
- Keep your data safe and secure and process it in a way that accords with your wishes.
- Use cookies (but only those which do not personally identify you) to improve the quality and relevance of the messages we send you.
- Assist you to change your mind at any time about the communications you have agreed to receive.
- Only disclose your data to third parties for marketing purposes when you have agreed to this.

Goniec Polski is a trading name of 1MM Media Ltd whose registered office is 58 Uxbridge Road, London W5 2ST with the registration number 07235735.

1MM Media Ltd is a wholly owned subsidiary company of One Money Mail Ltd.

### **Where your data is held**

Your data is held on secure servers operated by 1MM Media Ltd in the UK, and will be stored under the robust security measures described below.

We do not transfer your data outside of the EEA and we comply absolutely with the protection offered to you under the Data Protection Act 1998.

### **Data Security**

When you give your personal data to Goniec Polski and 1MM Media Ltd we will process that data in accordance with our responsibilities under the Data Protection Act 1998, and the Privacy and Electronic Communications (EC Directive) Regulations 2003 and other relevant legislation.

We will keep your data safe and secure. To prevent unauthorised access, maintain data accuracy and ensure the correct usage of information, we monitor and adjust our physical and electronic procedures to safeguard and secure your personal data while in our care.

### How we use your data

We will process the data you supply to provide you with carefully selected information about our products, services or events which might be of interest to you, and to provide any other service you have requested. We will only use your personal data for the purposes you have permitted and we will not share it for marketing purposes outside of 1MM Media Ltd and its parent company unless you have given us permission to do.

### How we use cookies

‘Cookies’ are small text files that are stored by your web browser on your computer’s hard drive.

We use this information to track your movements through our website to find out how it is being used and to improve your experience. The information we collect this way is non-personally identifiable.

Cookies may be session based (i.e. they expire when the browser session ends) or persistent (they remain on your hard drive for a longer period of time). We use both types of cookies.
